Dear Chair,

The Committee on Industry, Research and Energy and the Committee on the Internal Market and Consumer Protection, in accordance with Rule 129 of the Rules of Procedure of the European Parliament, held a public confirmation hearing on 12 November 2024 with Ms Virkkunen, Executive Vice-President-designate, who, subject to the positive outcome of the nomination procedure, will be responsible for Tech Sovereignty, Security and Democracy.

On 16 October 2024, our Committees, pursuant to Rule 129 of the Rules of Procedure and Article 3 of Annex VII thereto, received the letter from the Chair of the Committee on Legal Affairs regarding the scrutiny of the declaration of interests of Ms Virkkunen.

Prior to the confirmation hearing, Parliament had sent the Executive Vice-President-designate a list of written questions. Our Committees noted that Ms Virkkunen answered those questions in a satisfactory manner.


The course of the confirmation hearing is described in the verbatim transcript of the proceedings, where the commitments made are reflected.

In accordance with Rule 129 of the Rules of Procedure and Article 5 of Annex VII thereto, the coordinators of our Committees, representing a large majority of at least two thirds of committee members belonging to a political group, agreed at their evaluation meeting of 20 November 2024 that Ms Virkkunen is qualified to be a member of the College of Commissioners and to carry out the specific tasks assigned.

The opinions of the Committee on Civil Liberties, Justice and Home Affairs, the Committee on Legal Affairs, the Committee on Foreign Affairs and the Committee on Culture and Education, invited to participate in the confirmation hearing, are annexed to this letter.


